


Geographic locations: The product is produced in India and in Portugal. The use and the end of life phase occur in Colombia.

The database used was the Ecoinvent EN 15804 add-on, version 3.10. The database was used to determine the life cycle inventory and impact assessment of upstream and downstream stages and to determine the impact assessment of the core stage.

SCOPE OF THE STUDY

All the stages of the life cycle are included (cradle to grave).

The installation area required is quite small, without compromising operational simplicity and accessibility for maintenance.

Equipment is operated exclusively from the front, which allows Normacel switchgear units to be wall-mounted, reducing even further the area required.

The construction of Normacel switchgear is internal arc resistant, in accordance with IEC 62271-200, PM type, AFLR accessibility, for the protection of personnel and other equipment.




Cubicles are equipped with DIVAC-type withdrawable vacuum circuit breakers, with high electrical and mechanical performance in accordance with IEC 62271-200, E3 and M2 classes. Withdrawable contactors can be used for switching motors.

The continuous development of this product range allows us to achieve high performance levels, with rated currents of up to 4000 A and short-circuit currents up to 50 kA.

Declared/ Functional Unit: A unit of final product (Normacel).

Reference Service Life (RSL): Twenty years.

Presence of dangerous substances: No substances of concern or very high concern are present in the final product nor are expected to be released during use phase.

The core module consists of assembling the components and manufacturing the final product.

The Normacel range includes Medium Voltage Switchgear with air-insulation and modular metal-clad construction that is easily extendable.

The Normacel production process (core module - gate to gate) consists of assembling the final components/sub-assemblies, carrying out final tests and packaging/preparing for dispatch.

At Efacec India is assembled DIVAC (circuit breaker) and QBN7 SAK (the initial steps of the switchboard (final product)) assembly. At Efacec Portugal are performed the final assembly operations, customization operations and final functional and quality tests.

Assembly involves several stages using hand tools and electrical equipment. Electrical devices and equipment are also used for testing, so only electrical energy is consumed in the core module. There is also no consumption or use of other raw materials (apart from those included in the BOM (bill of materials), whose production is included in the upstream module) or auxiliaries in the production process.

The next figures represent the flowcharts of these assembly processes.




Figure 2 - Normacel - Assembly at Efacec India - Flowchart




Figure 3 - Normacel - Assembly at Efacec Portugal - Flowchart

Geographic boundaries:

The manufacture of raw materials and components is carried out globally, with special emphasis on India. Product assembly starts at Efacec India and ends at Efacec Portugal, where at least customization and final tests are carried out.

The distribution, installation, use and end of life stages are: Colombia.
